Staff shortages and burnout among the health-care workers who remain are exacerbating the crisis.

Health-care workers continue to face unprecedented pressure after more than two years of pandemic response. The combination of spikes in demand (a result of public health measures that failed to contain the virus), changing workforce demographics, political hostility, bad faith bargaining, lack of investment, an emphasis on "efficiency" over preparedness, and poor working conditions has fomented into a perfect storm.

Instead of turning to costly short-term measures like outsourcing, Alberta needs to pursue a provincial health workforce strategy and collaborate on a national plan to improve working conditions, recruitment, and retention of health-care workers. This must include system-wide supports for health-care workers who are experiencing and/or are at risk of burnout and trauma.

Rather than continuing along a path of political hostility, undercutting, and privatization of our health-care system, we can choose to examine the evidence and learn from examples from around the world.











Better Way Alberta: Re-Invest in World-Class Post-Secondary Education

Ilberta's post-secondary education system has suffered decades of neglect. Aside from a modest reinvestment in buildings and infrastructure during the boom-fueled early 2000s, the default government approach towards post-secondary education has been austerity.

Better Way Alberta: Take Action to Fight Inflation

rom gas to groceries, inflation is soaring to levels not experienced since the 1980s. Average Albertans cannot shoulder this on their own, and more and more working families are falling behind.

Here's how:

- **1.** Implement regulatory oversight and price controls to reign in price gouging.
- 2. Implement an excess profit tax to redistribute surplus wealth and disincentivize predatory profiteering by big businesses.
- **3.** Promote the widespread adoption of cost-of-living adjustments (COLAs) that tie wages to inflation in employment contracts and collective agreements.
- **4.** Make it easier for workers to unionize and negotiate collectively by implementing single-step union certification.

At the same time, Canadian corporations are reporting record profits. While ordinary people struggle to keep up, corporations are taking advantage of inflation to raise prices even higher, gouging consumers to generate excess profits. And many employers are refusing to provide wage adjustments to ensure workers' pay keeps pace with the cost-of-living.

There is a better way. Together, we can tackle inflation and protect working families from predatory profiteering.

Workers have shouldered the brunt of the fallout from economic, health, and social pressures and pay a far higher tax rate than corporations to keep our communities running. The last three years have shown us that we need to have built-in protections, not only to keep people safe but to also protect their financial health. We must put in place levers that stop corporations from taking advantage of working Albertans, and we must do it now.











Better Way Alberta: Revenue Reform

lberta is one of the wealthiest jurisdictions in the world. Yet our healthcare system is in crisis, too many children are in overflowing classrooms without enough supports, universities and colleges are being cut while student tuition is going up, and way too many families are struggling to make ends meet and falling into poverty. The so-called "Alberta tax advantage" is really only an advantage for profitable corporations and wealthy people.

There is a better way. The Alberta government can create a more fair and equitable revenue system that strengthens our economy and enables us to invest in high quality public services that benefit everyone.

As Alberta's population grows to more than 4.5 million people, government funding needs to keep pace so we can invest in schools, hospitals, municipalities, transportation, and building infrastructure. We also must commit to increasing the number of educators, healthcare professionals, and front line workers who have been stretched to the limit by funding cuts, understaffing, and lack of support.

It's time to make our tax system more fair for working families. Alberta can raise an additional \$5 billion to \$15 billion annually to invest back into communities and public services if the wealthiest 10% paid their fair share. This would avoid putting any additional pressure on the 90% of hardworking Albertans who have been shouldering the brunt of the investments into our province.

Here's how:

- **1.** Make the wealthy pay their fair share by implementing a more progressive income tax system and establishing a wealth tax on luxury goods.
- **2.** Make highly profitable corporations pay their fair share by closing loopholes and taxing excess profits.
- **3.** Eliminate public subsidies for highly profitable corporations.
- **4.** Raise royalty rates to ensure resource development benefits all Albertans, now and for the future.
- **5.** Direct new tax revenue from the wealthy and highly profitable corporations to cost relief for hardworking Albertans and improving public services for the benefit of everyone.











Better Way Alberta: Retirement Security

growing number of workers in Alberta don't have adequate savings for a secure retirement. The CPP was designed to be inadequate—CPP benefits have been capped at \$15,043 a year. The CPP was intended as a supplement, not as a liveable income for retirement. But fewer employers are providing workplace pensions, leaving many Albertans dependent on the CPP alone.

To make matters worse, instead of strengthening retirement security, our government has threatened to pull Alberta out of the CPP and create a new and duplicate, inferior pension plan. But the CPP belongs to Alberta workers, and making our pensions vulnerable to political agendas puts the future of Albertans at risk.

There is a better way. We can support workers to ensure that everyone in Alberta can count on a fair, liveable, and secure retirement income.

Albertans have shown very little confidence in the current Alberta government to manage investments fruitfully, having been shaken by issues with AimCo and costly private ventures and political projects that have returned little to no value to tax paying citizens. Not only that, but pulling Alberta out of the CPP will result in fewer benefits and higher costs.

To build a better future in Alberta, we need stability, opportunity, and a good standard of living to be available to all Alberta citizens at every stage of their working lives.

Here's how:

- **1.** Keep Alberta in the CPP and work with the federal government to improve it.
- 2. Protect our contributions by excluding politicians from CPP investment decisions and leave these decisions to independent investment experts.
- **3.** Mandate employers in Alberta to contribute to retirement plans for their employees.
- **4.** Promote cost-of-living adjustments (COLAs) that tie retirement benefits to inflation in employment contracts and collective agreements.
- **5.** Make it easier for workers to unionize and negotiate collectively by implementing single-step union certification.











Better Way Alberta: Respect & Rights for Workers

ard-won laws to protect workers have not kept pace with the changing nature of work and new understandings of health and wellness. A growing number of workers are falling through the cracks. Exceptions and loopholes have eaten away at the Employment Standards Code, Labour Relations Code, Occupational Health and Safety, and Workers Compensation. Vulnerable workers fall prey to unsafe working conditions. Legislation is often toothless without serious government oversight and enforcement, all too often leaving workers to fight for their rights on their own against powerful corporations.

There is a better way. Together we can show hard-working Albertans the respect they deserve by strengthening our laws—and holding employers accountable for following them.

Albertans are proud of their work. They can see the buildings that were built by their hands, they can speak to the lives that they have saved in hospitals, and they can drive on the roads that they have paved. Our government must ensure that workers are empowered to demand the respect and protections they deserve, and that they benefit fairly from their hard work and contributions to our economy.

Here's how:

- Expand the Employment Standards Code to cover all workers, including farm workers, contract employees, sales workers, and gig workers, and raise the bar for workers' rights and protections from the bare minimum.
- **2.** Expand the Workers Compensation Act to address less visible workplace illness and injuries, like mental health impacts and the spread of diseases like COVID-19.
- **3.** Ban injury-free workplace incentives that dissuade workers from reporting incidents.
- 4. Implement stronger oversight and enforcement of the Employment Standards Code, Labour Relations Code, and Occupational Health and Safety legislation to ensure employers are following the law.
- 5. Break down the current barriers for workers to unionize and negotiate collectively for fair pay and working conditions by implementing single-step union certification, while ensuring that punishments and enforcement of union busting tactics like terminations are significant enough to deter employers from acting illegally.
